1. Population Needs

1.1 National/local context and evidence base

Locally requests are received for repeated revisional spinal fusion surgery or spinal cord stimulator.

NICE Guidance in the management of lower back pain suggests that repeated revisional spinal fusion surgery may not be effective.

The Dorset Spinal Pathway promotes a multidisciplinary approach and effective triage leads to the identification of patients who would benefit from a spinal surgical opinion and potential surgical intervention.

The Spinal MDT clinic was developed to enhance the existing pathway and ensure best clinical management of patients with complex spinal problems.

2.2 Local defined outcomes

Agreement across specialties on the appropriate clinical management of complex and failed back patients including:

- referral for revisional spinal surgery;
- referral for spinal cord stimulator.

Improved patient experience.

3. Scope

3.1 Aims and objectives of service

The aim of the spinal MDT clinic is to assess complex/failed back patients not suitable for pain clinic assessments to be considered for a Spinal Cord Stimulator or revisional spinal fusion surgery by a multi-disciplinary team who will then jointly agree the most appropriate treatment plan for each patient.

3.2 Service description/care pathway

The MDT clinics will be located in an out-patient setting.

There will be up to 12 clinics per year with 4 - 6 patients attending each clinic.

The multi-disciplinary team will consist of a:

- rheumatologist;
- pain consultant;
- spinal surgeon;
- clinical psychologist/member of MDT specialising in pain management.

Patients will be identified for referral to the MDT clinic by the following referral sources:

- PHFT spinal MDT;
- University Hospitals Southampton(UHS) spinal MDT;
- spinal surgery providers including Ramsey New Hall Hospital, UHS and Spire Hospital Southampton;
- pain services at PHFT, The Royal Bournemouth Hospital and Dorset County Hospital;
- NHS Dorset Cluster Individual Treatment Requests Panel/Team.

All referrals will be reviewed and triaged by the members of the multi-disciplinary team to jointly agree the most clinically appropriate pathway for each patient:

- MDT clinic assessment;
- direct referral for Spinal Cord Stimulator or spinal surgery without clinic assessment;
- direct referral to rheumatology/pain services.

PHFT will identify a single point of contact for administration of referrals and communication between the multi-disciplinary team, referrers and the PCT.

Patients attending the spinal MDT clinic will be seen by each member of the multi-disciplinary team individually during a single out-patient attendance.

On completion of the individual patient assessments, the MDT will meet on the same day to discuss and jointly agree the most appropriate treatment plan for each patient.

3.3 Any acceptance and exclusion criteria and thresholds

The service will be available to adult patients aged over 18 years who are registered with a Dorset CCG General Practitioner.
